Vehicle Registration and BCCA Stickers

The Association Office requires **annual** copies of your vehicle registration. This is necessary for several reasons:

- In case of an emergency (garage pipe leak, etc.) we will be able to notify the owner of a vehicle.
- Residents change vehicles without notification to the office, which makes it difficult to track down the owner of a vehicle.
- Our database of owner information includes vehicle information which has shown to be very useful when needed (vehicles illegally parked, vehicles left running in the garage, etc.)
- Please make sure vehicles are registered with the office.
- **Vehicle stickers** are required to be displayed on the passenger rear or side window.
- BCCA vehicle stickers are available at the office free of charge with the vehicle registration.
